- 1. Class starts on 3/2/2024 ending on 4/20/2024. Classes are held in the Driver's Education Room Suite 210 8AM-10AM. Cost is \$895.00 There will be a mandatory parent/guardian (mother and/or father) meeting held at 75 Gilcreast Rd. Suite 210 Londonderry, NH 03053 on Thursday 2/29/24 from 6pm 7pm in Driver's Education Room Suite 210
- 2. Student must be NO Younger than 15 and 9months by the first day of class and will provide a copy of birth certificate in proof of this. Student agrees to attend all scheduled classes.
- 3. Please be prompt to classes. Students are not allowed to miss more than a total of 4 hours of class for any reason. ALSO, FOR THOSE FOUR HOURS YOU WILL NEED A NOTE STATING SICKNESS, INJURY, OR FUNERAL IF NOT IT WILL RESULT IN AN INCOMPLETION OR FAILING GRADE FOR THIS COURSE. There will be NO exceptions, as this is a STATE REGULATION.
- 4. All students must comply with the rules of Mr. Ross driving school as outlined in this contract. All students are required to have some knowledge of the street signs. Visit http://www.nh.gov/safety/divisions/dmv/forms/documents/nhdm.pdf

Each road instructor will post his or her schedule in advance if a student misses a driving lesson without at least 24 hours' notice, and/or an excused absence as stated in this contract, then they will be required to pay a missed driving lesson fee of \$75.00.
- 6. Cancellations of a driving lesson must be done 24 hours prior to the scheduled lesson; please call your driving instructor. You will not be charged if you call.
- 7. Cancellation of class due to bad weather will be announced by the instructor. If school is canceled, then driver's education classes and driving lessons are canceled for the day unless you hear from your instructor.
- 8. Students must satisfactorily complete 10 hours of driving and 10 hours of observation.
