DRIVER EDUCATION RULES / PERMISSION FORM

APPLICATION'S MUST BE COMPLETED IN FULL OR WILL NOT BE ACCEPTED

1. **Class starts on 5/3/2025 ending on 6/22/2025. Classes are held in the Driver's Education Room Suite 210 8AM-10AM. Cost is \$895.00 There will be a mandatory parent/guardian (mother and/or father) meeting held at 75 Gilcreast Rd. Suite 210 Londonderry, NH 03053 on Thursday 5/1/25 from 6pm - 7pm in Driver's Education Room Suite 210**
2. **Student must be NO Younger than 15 and 9months by the first day of class** and will provide a copy of birth certificate in proof of this. **Student agrees to attend all scheduled classes.**
3. Please be prompt to classes. Students are not allowed to miss more than a total of 4 hours of class for any reason. ALSO, FOR THOSE FOUR HOURS YOU WILL NEED A NOTE STATING SICKNESS, INJURY, OR FUNERAL IF NOT IT WILL RESULT IN AN INCOMPLETION OR FAILING GRADE FOR THIS COURSE. There will be NO exceptions, as this is a STATE REGULATION.
4. All students must comply with the rules of Mr. Ross driving school as outlined in this contract. All students are required to have some knowledge of the street signs. Visit <http://www.nh.gov/safety/divisions/dmv/forms/documents/nhdm.pdf> Attendance in class is required. If a student is absent from class, then they must seek make up work from their class instructor. However, no student can miss more **than two classes**. If they miss more than two classes, then they will be asked to leave the class with **no refund**.
5. Driving lessons are scheduled in advance. Each road instructor will post his or her schedule in advance if a student misses a driving lesson without at least 24 hours' notice and/or an excused absence as stated in this contract, then they will be required to pay a missed driving lesson fee of **\$75.00**.
6. Cancellations of a driving lesson must be done 24 hours prior to the scheduled lesson; please call your driving instructor. You will not be charged if you call.
7. Cancellation of class due to bad weather will be announced by the instructor. If school is canceled, then driver's education classes and driving lessons are canceled for the day unless you hear from your instructor.
8. Students must satisfactorily complete 10 hours of driving and 10 hours of observation.
9. Students must satisfactorily complete and pass the class requirements of their class instructor.
10. Students will be required to document 40 hours of driving and submit it to the DMV.
11. **No students will be given a green slip (showing successful completion of Driver Education) that have not paid in full, and/or have not returned textbooks; all assigned classroom work has not been completed and turned in before the last class.**
12. Upon successful completion of Driver Education, all paperwork, including green slip, will be given out or mailed.

13. There will be **NO FOOD OR DRINKS** allowed in the classroom. Except for bottled water with cap.
14. Students arriving more than 5 minutes late to class will be considered absent.
15. All students must pass an eye test prior to the first day of class. 20/40 is passing.
16. Students must adhere to State Eligibility Requirements, to successfully complete the course. I have read, understand, and agree to abide by the Driver Education Rules which are subject to change in accordance with the requirements of the State of New Hampshire.
17. No cell phones, will be used in the classroom, will be placed in a box in front of the classroom smart watches should only be used to read the time. no cell phones in restroom, no cell phones to be used in the car, cell phones will be put aside in the car as well. no earbuds of any sort will be used in the classroom or in the car.
18. No smoking in or outside the building area no vaping of any sort this would cause for immediate termination without refund.
19. Refund: The \$350.00 nonrefundable deposit is due with the application. The remaining balance must be paid in full by the parents meeting which is held on the last Thursday 5-1-25 before the start of the first class. If you need to cancel, please give a minimum of a one - week notice, in any amount less than deposit would be refunded in less than 30 days
20. Payment: **With the application there must be a \$350.00 non-refundable deposit** the remaining balance must be paid in full by the parents meeting which is held on the last **Thursday 5-1-25** before the start of the first class.
21. Class: **The class includes 30 hours of classroom instruction, 10 hours of driving instruction, 10 hours of observation.**
